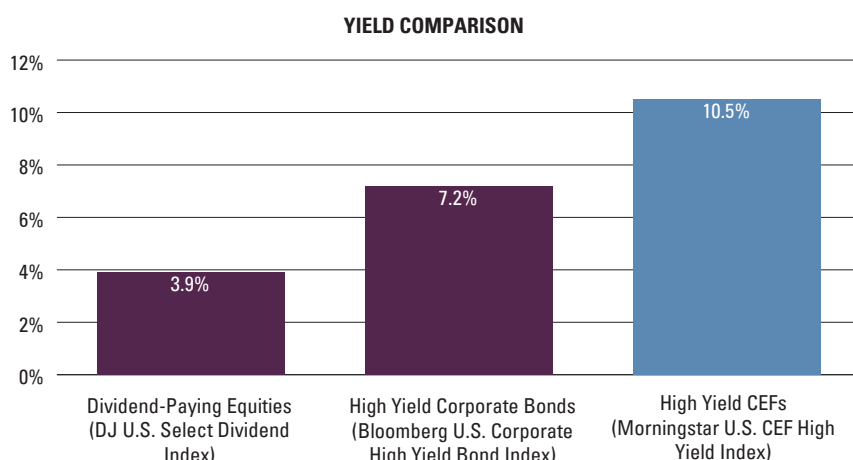


Corporate High Yield & Income Portfolio of CEFs, Series 51

An Attractive Choice for Income-Focused Investors

Due to their distinct structure, closed-end funds (CEFs) may offer the potential for higher consistent income than other types of investments. CEFs that consist of high yield corporate bonds² can provide attractive distributions, offer diversification benefits, as well as help reduce interest rate sensitivity for those investors willing to assume additional risks.

To provide exposure to these high income bonds, Guggenheim Funds Distributors, LLC created the Corporate High Yield & Income Portfolio of CEFs. The Trust utilizes a comprehensive multi-factor security evaluation to construct a diversified portfolio of high yield corporate bond funds that have historically delivered equity-like returns, comparatively lower risk, and an attractive income stream.

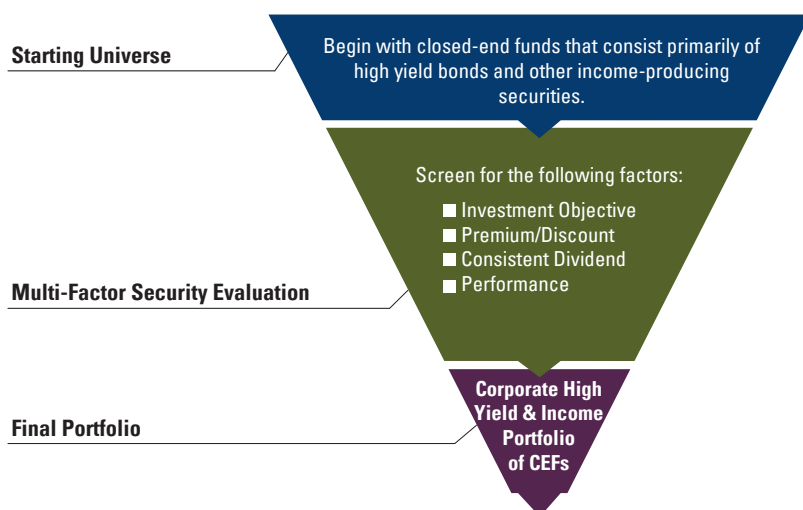

INDEX DEFINITIONS: The **DJ U.S. Select Dividend Index** aims to represent the U.S.'s leading stocks by dividend yield. The **Bloomberg U.S. Corporate High Yield Bond Index** measures the U.S. dollar-denominated, high yield, fixed-rate corporate bond market. Securities are classified as High Yield if the middle rating of Moody's, Fitch and S&P is Ba1/BB+/BB+ or below. The **Morningstar U.S. CEF High Yield Index** consists of U.S.-listed CEFs that seek high current income through investing in non-investment grade debt instruments.

Investment Objective

The Corporate High Yield & Income Portfolio of CEFs, Series 51 (Trust) seeks to provide current income and the potential for capital appreciation.

Key Considerations

- **Enhanced Risk/Reward:** High yield corporate bonds have historically delivered competitive returns with comparatively lower risk than equities.
- **Diversification:** Typically, high yield corporate bonds have a low correlation to investment-grade bonds and may be an effective tool for enhancing portfolio diversification.
- **Attractive Income Potential:** Investors seeking income and willing to assume the additional risks involved may find opportunity in high yield corporate bonds. The Trust's historical annual dividend distribution is \$1.0684,¹ as of 8.4.2026.

Advantages of Closed-End Funds

Many closed-end funds (CEFs) are designed to periodically distribute income to shareholders. In addition, CEFs have historically traded at a discount to their net asset value and their structure allows for the employment of leverage. These features may help investors realize enhanced total returns.* Other advantages of CEFs include:

- Exchange listing
- Price visibility
- Intraday trading
- Professional management

As a professionally selected, defined, and fixed portfolio of managed CEFs, the Trust may provide an extra degree of diversification for those investors seeking monthly-income potential.**

* There is increased volatility associated with investing in leveraged funds. ** Despite broad diversification, it is important to note that certain CEFs selected for the portfolio invest in bonds rated below investment-grade (sometimes referred to as "junk bonds"). These bonds are considered speculative and are traditionally subject to greater credit risk and therefore their risk of default may be greater than normal. The HADD is the weighted average of the trailing twelve-month distributions paid by the securities included in the portfolio and is reduced to account for the effects of fees and expenses, which will be incurred when investing in the Trust.
